In consideration of being permitted to participate in the Suzuki Contingency Program during the 2010 season, Guardian(s) and Racer, on behalf of Racer, Racer's successors, heirs, assigns, minors, and incompetent persons (if any), release and forever discharge American Suzuki Motor Corporation ("ASMC"), its parent company, and each of their affiliates and related companies, agents, employees, servants, officers, directors, and authorized dealers (collectively "Released Parties") from all claims, actions, suits, or judgments I may have or claim to have against ASMC and Released Parties, either now or in the future. Guardian(s) and Racer agree, on behalf of Racer, that Racer is solely responsible for all personal injuries, including death, and damage to property, either real or personal, caused by or arising out of or in any way relating to Racer's participation in the Suzuki Motorcycle Contingency Program for 2010, including any and all injuries, death, or property damage occurring either in whole or in part as a result of ASMC and the Released Parties' active, gross, or other negligence (if any). Guardian(s) and Racer make this release and discharge with full knowledge that motorcycle racing is a hazardous activity, and that it is impossible to predict the existence or severity of any hazards or defects that may exist at the locations where the races will be held.

Guardian(s) and Racer further agree on behalf of Racer, Racer's successors, heirs, assigns, minors, and incompetent persons (if any) to indemnify and hold ASMC and the Released Parties harmless from and against any and all claims, actions, suits, or judgments for personal injuries, including death, and damage to property, either real or personal, arising out of or in any way relating to Racer's participation in the Suzuki Motorcycle Contingency Program for 2010, and from and against any and all expenses (including costs and attorneys' fees) incurred in defending said claims, actions, or suits, including any and all judgments or expenses occurring in whole or in part as a result of the Released Parties' active, gross, or other negligence (if any).

Guardian(s) and Racer further agree that without any additional compensation, Racer's name, photographs, pictures, voice, likeness, slides, movies, or other reproductions, regardless of type or medium, taken of Racer or made in connection with Racer's participation in the Suzuki Motorcycle Contingency Program for 2010, and any copies of the same, may in any manner or media be used by ASMC, or by any person, corporation, or association authorized by ASMC.

Guardian(s) and Racer represent and warrant that Racer is in good health and has no physical conditions that would prevent Racer from participating in motorcycle racing.

Guardian(s) and Racer expressly agree that Racer will fully abide with all the rules of the 2010 Suzuki Motorcycle Contingency Program, which Guardian(s) and Racer have read at [www.suzukicycles.com/racing](http://www.suzukicycles.com/racing).

Guardian(s) and Racer expressly understand and agree that Racer and/or Guardian(s) must own the motorcycle(s) raced by Racer in the contingency races in order to receive payment. Guardian(s) and Racer agree to include proof of ownership.\* Guardian(s) and Racer agree, on behalf of Racer, to complete this application and submit it to ASMC within 30 days after Racer's first event in order to qualify for payment. Guardian(s) and Racer agree, on behalf of Racer that applications submitted after the 30 day period will not be eligible for payment. Guardian(s) and Racer agree and acknowledge that it is Racer's responsibility to resolve race result disputes with the race organization, and that ASMC will only make payments based on results provided by the race organization.

Guardian(s) and Racer agree and acknowledge that professionals and amateurs will both receive a reloadable Suzuki Rewards Card only redeemable at authorized U.S. Suzuki dealerships.

Guardian(s) and Racer, on behalf of Racer agree and acknowledge that section 1542 of the California Civil Code states that a general release does not extend to claims which Racer does not know exist, or does not suspect exist at the time of signing the release, and which, if Guardian(s) and/or Racer knew of or suspected such claims exist, would have materially affected Guardian(s) and Racer's willingness to sign the release. Notwithstanding the language of section 1542, and with full knowledge and understanding thereof, by signing below, **GUARDIAN(S) AND RACER, ON BEHALF OF RACER HEREBY WAIVE RACER'S RIGHTS under section 1542 of the Civil Code of California or any similar law of any other state, and Guardian(s) and Racer acknowledge that this waiver is an essential term of this release without which ASMC and the Released Parties would not have allowed Racer to participate in the Contingency Program.**
